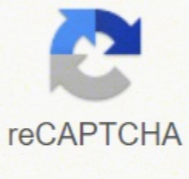

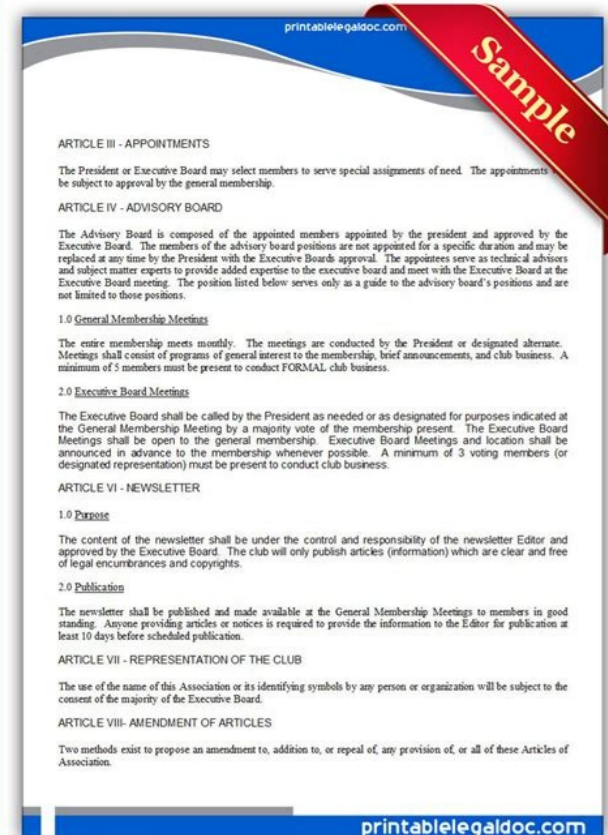

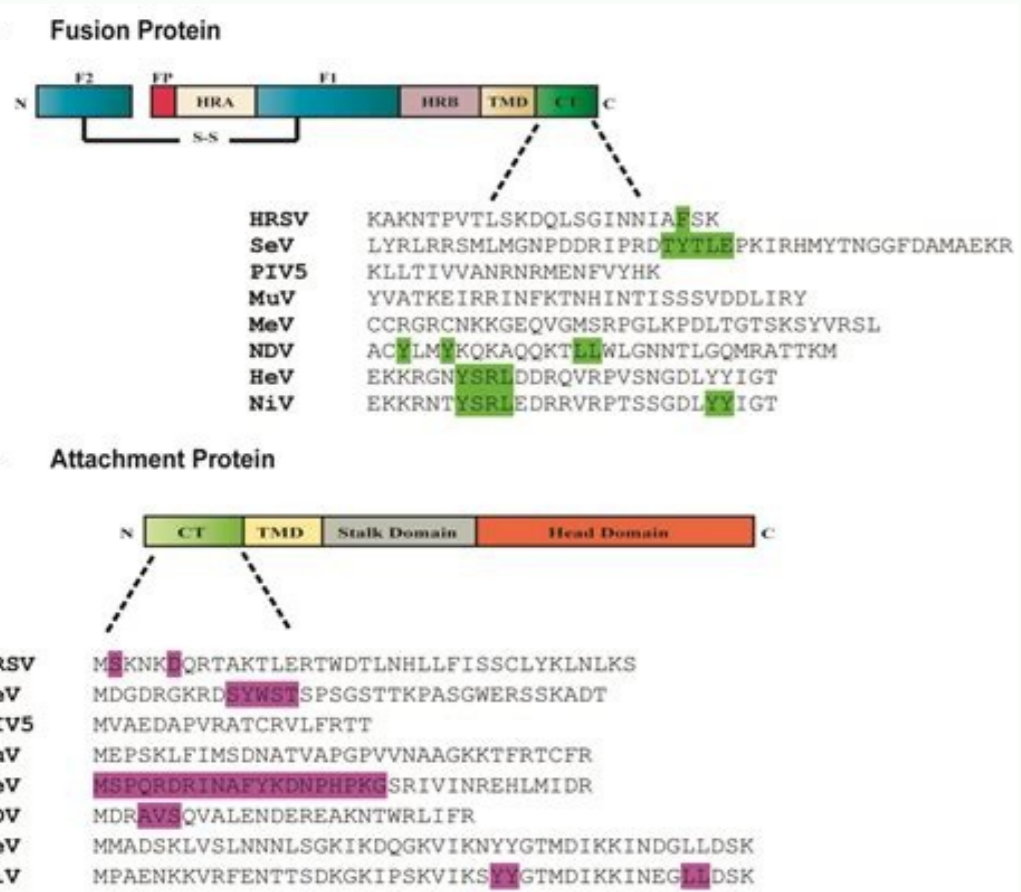
Articles of Incorporation of Domestic Nonprofit Corporation
Form DNP-1, Version 3, January 2012.

One or more persons acting as the incorporator or incorporators under the provisions of the Title 29 of D.C. Code (Business Organizations Act) adopt the following Articles of Incorporation:

1. Corporation Name.
2. The corporation will have members. Yes No
3. Registered Agent's name and address in the District Columbia.
4. The corporation is incorporated as a nonprofit corporation under D.C. Code Title 29 Chapter 4.
5. Miscellaneous Provisions. (may attach the statement)
6. Incorporators Name & Address. 6A. Incorporators Signature and Date.
7. Incorporators Name & Address. 7A. Incorporators Signature and Date.

Although the exact requirements differ from state to state, you generally need your corporation Most corporations are perpetual, meaning that they continue until they are dissolved. What should Articles of Incorporation include? Our form is easy to complete, easy to understand, and easy for state agencies to process. An address is usually required. Article VI: Statement of Acceptance by Registered Agent Some states require registered agents to confirm their appointment with a signed statement. Once filed, some states send you a Certificate of Incorporation, while others just return your Articles of Incorporation with a stamp of approval. The incorporator can be a director or officer, or someone you authorize to fill out this paperwork. Article X: Bylaws This section notes that the corporation will adopt initial bylaws. This way, no one is appointed without their knowledge. For instance, in Missouri, your filing fee increases if you have more than \$30K in combined par value.
